Standard Release of Liability

Boat owner and guests agree to hold harmless Patrick Enterprises Incorporated DBA Pistakee Lake Marina, its shareholders and employees from any personal injury or property damage claim resulting from occupation and use of the marina and it's facilities.

I understand that all service work is COD and will pay promptly when invoiced for the work that I have requested. We do not maintain open accounts. After 60 days interest and late fee charges will accrue. Boat will not be released until payment is made in full. If collection is made I agree to pay interest until paid in full, all collection costs, late charges and attorneys costs. I agree to hold harmless Patrick Enterprises Incorporated, DBA Pistakee Lake Marina, for loss or damage to boat, motor, trailer, contents, electronics, and power train. In the event boat is left on the property with no arrangements with harbor office, storage charges apply at the rate of \$100.00 per foot per summer and winter season cycles. This agreement will remain and preside as long as boat is stored wet or dry on the property. Any fees due PLM will be deducted from the final value of the boat. All storage costs are invoiced on a seasonal basis or other agreed upon terms and must be paid for when due. On occasion we may show your boat at a boat show, by signing this you are giving us approval.
